CHANGE OF COMPANY NAME, STOCK SHORT NAME, COMPANY WEBSITE, HEADQUARTER AND PRINCIPAL PLACE OF BUSINESS IN HONG KONG AND TELEPHONE NUMBER

References are made to the announcement of World Digital Economy Asset Group Limited (formerly known as “China Supply Chain Holdings Limited”) (the “**Company**”) dated 9 December 2025, the circular of the Company dated 19 December 2025 (the “**Circular**”) and the poll results announcement of the extraordinary general meeting of the Company (“**EGM**”) dated 9 January 2026 in relation to, the Proposed Change of Company Name. Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that following the passing of a special resolution approving the Proposed Change of Company Name by the Shareholders at the EGM, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands certifying that the English name of the Company has been changed from “China Supply Chain Holdings Limited” to “World Digital Economy Asset Group Limited” and the dual foreign name in Chinese from “中國供應鏈產業集團有限公司” to “世界數字經濟產業集團有限公司” (the “**Change of Company Name**”), with effect from 29 January 2026. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 February 2026 confirming the registration of the English name of the Company from “China Supply Chain Holdings Limited” to “World Digital Economy Asset Group Limited” and the Chinese name of the Company from “中國供應鏈產業集團有限公司” to “世界數字經濟產業集團有限公司” in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “CH SUPPLY CHAIN” to “WORLD DIGI ECON” in English and from “中國供應鏈產業” to “世界數字經濟產業” in Chinese with effect from 9:00 a.m. on 5 March 2026.

The stock code of the Company on the Stock Exchange will remain unchanged as “3708”.

EFFECTS OF CHANGE OF COMPANY NAME AND STOCK SHORT NAME

The Change of Company Name and the change of the stock short name will not affect any rights of the existing Shareholders or the Company’s daily business operation and its financial position. All existing share certificates in issue bearing the former names of the Company will continue to be evidence of title to such Shares and valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for free exchange of the existing share certificates of the Company for new share certificates printed in the new names of the Company. With effect from 5 March 2026, any new share certificates will be issued only in the new names of the Company.

CHANGE OF COMPANY WEBSITE

The website of the Company will be changed to “www.wdeag.com/index.php” to reflect the Change of Company Name with effect from 2 March 2026.

CHANGE OF HEADQUARTER AND PRINCIPAL PLACE OF BUSINESS IN HONG KONG

The address of the headquarter and principal place of business of the Company in Hong Kong will be changed to Unit 21A, 21/F, Kingston International Centre, 19 Wang Chiu Road, Kowloon Bay, Hong Kong with effect from 2 March 2026.
